business hours (Monday – Friday 12:00 – 4:00 PM), and
during scheduled performances.

Center for the Arts at Kayenta Visual Art Exhibitions

On behalf of the Center for the Arts at Kayenta, the Desert Spirit Art Committee organizes three, themed visual art exhibits each season in the Main Lobby of the Center for the Arts at Kayenta (CFAK).

The Committee seeks new artwork from established and emerging regional artists that reflects artistic excellence in execution, originality, and composition. A free reception is held on the Wednesday evening following the submission deadline to open the exhibit to the public and celebrate the exhibiting artists. The exhibitions are installed for up to two months and are free and open to the public during CFAK business hours as well as during performances and special events.

ARTWORK SUBMISSION REQUIREMENTS

- An artist may submit no more than two (2) original artworks for consideration (*giclées, serigraphs, and/or other commercial reproductions are not accepted*).
- Photography submissions are limited to an outside size of 18" x 24" (including frame) due to our limited display space and historically large number of entries.
- All submissions must be of new work (*completed within 12 months of the submission date*).

- The submission fee is \$5 per artwork (*cash or check only, fees are non-refundable*).
- All artwork should be titled ("*Untitled*" is not an acceptable title).
- Any artwork intended for hanging on a wall (*including textiles and ceramics*) must have the appropriate wire hanger(s) to safely accommodate the weight of the artwork. CFAK is not responsible for damage or repairs if the artwork does not meet this requirement.

EXHIBITION JURY

- For each exhibit, artwork is juried by two professional artists for inclusion in the exhibition. The jury members are different for each exhibit, allowing for varied perspectives and aesthetic tastes in the selection.
- If your artwork is not selected, it must be picked up prior to the exhibition opening date.

ARTWORK SALES

- All artwork must be available for purchase. CFAK retains a 25% commission on each purchase.
- CFAK manages all artwork purchases and issues checks to the artist once the exhibit has closed.
- Artwork sold during the exhibit may not be removed from the premises until the exhibit has closed.
- CFAK does not facilitate shipping any artwork. It is the artist's responsibility to negotiate shipping any artwork with a buyer.

RESPONSIBILITY FOR LOSS OR DAMAGE & INSURANCE COVERAGE

- CFAK shall be responsible for the safekeeping of all artwork while on the premises.
- CFAK shall be liable to the artist for loss of damage (*except for damage resulting in flaws inherent in the artwork*) to the following percentage breakdown, of the artist's commission, had the artworks sold: 50% coverage \$1 - \$999; 75% coverage \$1,000 - \$1,999; 95% coverage \$2,000 and above.

DELIVERY & COLLECTION OF ARTWORK (*Shipping artwork to or from CFAK is not allowed*)

- Artwork must be delivered, in person, to CFAK on the predetermined submission date.
- Unsold artwork must be collected, in person, from CFAK on the predetermined pickup date.

PUBLICITY

Photographs of entries may be used for publicity purposes on the CFAK website or other advertising venues.

By submitting your artwork for consideration to the CFAK Visual Art Exhibitions you understand and agree to the information above. The Jury is not accountable for submissions that do not adhere to the requirements/information as stated, and have the right to reject them on that basis.
